Hi to all our friends, supporters and prayer warriors. Thanks again for your prayers. Amy and I are both healthy and doing well. I puzzled over what to write. Not much has changed since my July news and prayer letter.

I keep puttering around at the museum each day 2 to 4 hours. I work on the model railroad which will be for the Juvenile Justice Center and elder care homes when they open up. I had to cancel all my schools for November but Lord willing I can restart in February. I get acute bronchitis during the winter sometimes, which makes me more susceptible to the virus. I was starting to have slight symptoms of bronchitis so I didn't want to take a chance that I could pick something up at one of my schools. Pictures shows the steam engine taking logs to the saw mill crossing a trestle made from skewer sticks from our kitchen since the hobby shop was closed for modeling supplies.



Those of you in Minnesota already know that I canceled the trip there and did my program on zoom with TCCSA.TC If you go to their website you can see and hear my program there. It was showing a comparison of the Giraffe and the apatosaurus blood circulatory system. The second part compared the bat to the biggest creature God created. This was the pterodactyl with a 40-foot wingspan. I explain each of its bones using pictures of my 40-foot model in the museum. Check it out at this website:

One new development came when I found out that one of the Vietnamese refugee young people that we sponsored 30 years ago lost her husband to cancer at age 55. They had been together 20 years. She is going through the same loss, heartbreak and grieving that I went through when Tricia died four years ago November 25, 2016. I'm thankful for the things that I experienced and learned when I lost Tricia. Now I can share with her and help her walk through this "valley of of the shadow of death and life changing experience. Please remember her in prayer and that I can have the right words to help her through this difficult time.

I applied for several government helps if I had lost income from the COVID-19. It seems that I am off the government grid because I'm self-employed and in mission work. I applied to three different types of aid but was turned down on all of them.

However, God has a disaster program for us through your prayers and financial help. That has sustained us, and we are so thankful for you who continue to support us even though you may be getting short on money too.

July 2 A young man rear-ended Amy at an intersection and her car was totaled. Thankfully she was not hurt too badly. We've been looking at used cars but have to wait for the insurance settlement. The young man had a \$30K Jeep but no insurance. Our car insurance lawyer is attempting to get compensation and the boy is on probation.

For the last eight years Tricia and I had two automobiles that were totally paid off. Amy's car was totally paid off. We had no payments for transportation. I traded my car in and sold my van and bought a new car in August 2019. I've had to make payments on that each month. Thankfully we have been able to do that.
